

## **Forced Migrants: Documentation Required**

As a Student visa sponsor, we have a legal responsibility to ensure that everyone registered to study with us has the correct immigration permission to do so. Unfortunately, we are unable to consider applications to study from students where their current immigration status is unclear or who do not currently hold an immigration status which allows study.

To ensure transparency, below we have detailed the documents we require for you to demonstrate that you meet the criteria to study. Please also note that if you are an asylum seeker or your immigration status is unclear, Birkbeck will require your consent to discuss your immigration history and status with the Home Office (HO) to ensure you have the right to study. This check will be completed once you have met all conditions of your offer and are ready to enrol. This status will be reconfirmed with the HO every six months.

Asylum Seeker, Appeals Rights Exhausted, no fresh claim	<ul style="list-style-type: none"> <li>- Unlikely to be accepted to study on a course at Birkbeck. Refugee Status (spouse, child, civil partner)	<ul style="list-style-type: none"> <li>- A valid E-Visa share code (previously a BRP card)**</li> <li>OR</li> <li>- Letter from HO confirming Refugee status</li> </ul>
Humanitarian Protection	<ul style="list-style-type: none"> <li>- A valid E-Visa share code (previously a BRP)**</li> <li>OR</li> <li>- Letter from HO confirming humanitarian protection</li> </ul>
Article 8 Application	<ul style="list-style-type: none"> <li>- Evidence of an in-time Further Leave to Remain application under ECHR Article 8***</li> </ul>

\*to ensure you can demonstrate that you have made an in-time application, you should provide your previous visa and evidence of the new application in the form of proof of postage and/or a letter from the Home Office confirming receipt of your application.
